**VIOLATIONS BUREAU CITATION:**

- You have been issued a citation with a court date and court location. Your failure to appear in court on the date specified on the citation, or otherwise respond to the citation as directed, may result in the suspension of your driver's license and/or a warrant being issued for your arrest.
- You have the following options to respond to the citation(s): Appear in court on the date specified on the uniform citation; OR plead guilty and pay in full prior to the court date.
- You will need to pay for each citation you have been issued.

**OPTIONS TO PLEAD GUILTY AND PAY YOUR FINE:**

- Use the Plead and Pay feature on Case.net. You may search for your case at: [www.courts.mo.gov/casenet](http://www.courts.mo.gov/casenet). You will need your citation number, located in the upper righthand corner of the citation. You **MUST** pay the entire amount due, plus an online processing fee. By using Plead and Pay, you are acknowledging the payment in full is a guilty plea and waive a court hearing to the charge on the citation.
- Up to 7 days prior, mail the signed Plea of Guilty Appearance and Waiver below, and return it with a check or money order (in US dollars) for the full amount due **payable to New Haven Municipal Court**. **Be sure to write the citation number(s) and your daytime phone number on the front of the check or money order. DO NOT MAIL CASH**
- Enclose a self-addressed, stamped envelope for return of receipt.
- Pay your fine in person during office hours.
- Pay your fine using our night deposit box- **The EXACT amount and ticket or copy of ticket MUST be enclosed with signed plea of guilty appearance and waiver. No change will be issued with this method.**

**THANK YOU FOR YOUR COOPERATION:**

- If your violation is not listed here or on our website, <https://www.newhavenmo.org> you **MUST** appear in court on the date specified.
- If you were involved in an accident, you **MUST** appear in court on the date specified.
- If your payment is not received on or before specified court date you MUST appear in court.**
- You may contest this complaint in court at address, date, and time on citation.
